### **Privacy Policy Commitment**

- We will protect, according to strict standards of security and confidentiality, any information our customers share with us.

- Only authorized employees will have access to information. Employees who violate our Privacy policies and procedures will be subject to our normal disciplinary process.

- We will always maintain control over the confidentiality of our customer information. We may, however, share customer information with reputable companies when a customer has expressed an interest in their service or product. Please note that this Privacy Policy does not apply to these other companies use of customer information.
- Should we hire other organizations to provide support services, we will require them to conform to our privacy standards and conduct occasional audits.
- We will attempt to keep customer files complete, up-to-date, and accurate. We will tell our
  customers how and where to conveniently access their information (except when we are
  prohibited by law) and how to notify us about errors which we will promptly correct.

## **Information We Collect**

**General:** When you register, and at other times, we may collect personally identifiable information from you that may include your name, address, telephone number, e-mail address, and facts about your computer. We do not, however, knowingly collect personal information from children under the age of thirteen. In addition, if a user is under 18, unless consent is obtained from your parent/guardian, you are not allowed to provide us with personal information.

**Web Site Usage Information:** We automatically collect IP addresses and Web site usage information from you when you visit our Web site. This information helps us evaluate how our visitors and customers use and navigate our Web site on an aggregate basis, including the number and frequency of visitors and customers to each Web page, and the length of their visits.

#### **How We Use Information Collected**

We may use information in the following ways:

- For the purposes for which you specifically provided the information.

- To enhance existing features or develop new features, products, and services.
- To allow us to personalize the content and advertising that you and others see based on personal characteristics or preferences.

  with information that you provide to us in connection with your use of our other products,
  services, and web site.
- We may disclose and use personally identifiable information in special circumstances where it is necessary to enforce our Terms of Use (for example, when necessary to protect our intellectual property rights). We may also disclose or use your personal information when we, in good faith, believe that the law requires us to do so.

### **Cookies**

We utilize cookie technology to help visitors and customers move faster through our site. When you sign on to our Web site or take advantage of several key features, we may pass cookies to your computer. A cookie is a string of information that is sent by a Web site and stored on your hard drive or temporarily in your computer's memory.

## **Security**

The personally identifiable information we collect about you is stored in limited access servers. We will maintain safeguards to protect the security of these servers and your personally identifiable information.

## **Internet-based Transfers**

Given that the Internet is a global environment, using the Internet to collect and process personal data necessarily involves the transmission of data on an international basis.
