- Posh Getaways by Paris, LLC acts as a travel agency only. We sell various travel related products on behalf of numerous transport service providers and accommodation service providers, including, but not limited to airlines, coach, rail, cruise line operators and hotels.
- Posh Getaways by Paris, LLC does not own, operate, manage or control these independent suppliers of services and is not liable for their acts or omissions.
- Posh Getaways by Paris, LLC obligations to you are to make travel bookings on your behalf
 and to arrange relevant contracts between you and the travel service providers. We have
 no responsibility for these services, nor do we have the authority to make any warranty or
 representation regarding their standard. A request cannot be guaranteed.
- All bookings are subject to the terms and conditions and limitations of liability imposed by
 these travel service providers. You understand that your legal recourse is against the
 specific provider not Posh Getaways by Paris, LLC. As a result, Posh Getaways by Paris, LLC is
 not liable for any negligent or willful act or failure to act of any such person or entity, or of
 any other third party.

PAYMENTS

Deposits

- A deposit is due at the time of reservation. No rooms or flights are held until a deposit is received.
- Deposits are nonrefundable and nontransferable. This is because we have contractual agreements with hotels, airlines, and other vendors that will not allow us to obtain refunds.
- Deposits are generally due within 3 days of a quote or placing a "hold" on a reservation. All quoted prices are subject to change until booked.
- A confirmation will be sent once the reservation is booked.

Refunds:

- All payments to Posh Getaways by Paris, LLC., are non-refundable and non-transferable.
- This is because Posh Getaways by Paris, LLC., has contractual agreements with hotels, airlines and other vendors that will not allow us to obtain any refunds. This way we can



keep our package prices competitive and allow you to make monthly payments on your vacation.

Why is my payment nonrefundable?

- We are providing a service which means:
 - We take packages out of inventory, in good faith, on a lay-a-way basis. Our vendors (hotels, tour companies, etc) require upfront commitments that we must adhere to.
 - We create customized accounts so that you can take advantage of affordable payment arrangements.
 - We provide a convenience of having everyone in your group pay with their own credit/debit cards.

Payments

- Our merchant account allows us to accept payments by major credit and debit cards, PayPal, and PayPal Later. We also accept payments over the phone (during office hours).
- Client can also login to a secure Client Portal to make payments and/or change the card on file at any time.
- Payments by certified bank check and money orders are limited to certain tours. If allowed, the trip description will clearly indicate so. Final payments by check will be due 60-days prior to departure. Certified check or money order must be made out to "Posh Getaways by Paris, LLC" and mailed to: P.O. Box 871024, Stone Mountain, GA 30087. There is a \$35 fee for all returned checks.
- Payment Options: 1) Automatic or 2) Manual
- Clients can select 1) Pay in Full, 2) Monthly Payments, or 3) Installments (if offered).

Automatic Payments

- Automatic billing is a convenient service that allows you to pay the remaining balance of your reservation using 1 credit card.
- Automatic payments reduce your risk of your trip being cancelled or assessed a Late Fee. There is no chance of forgetting to pay for your much-needed vacation!
- Payments are evenly divided and deducted automatically on or about the same day of the month you made your first payment. Receipts will be emailed. The number of payments is based on how many months remain between the time you book and the final payment date. The exact monthly payment plan will be shown when you make your reservation.
- Clients can modify their payment plan at any time, but no later than **5 days** before the next payment, by contacting the Travel Agent via email.
- If the card on file expires or a new card is issued, please update the card on file in the Client Portal or notify us immediately by email (Support@poshgetawaysbyparis.com) to make new payment arrangements. A new billing plan or invoice will be issued.
- If payment is **60 days** past due a payment and/or new plan arrangement must be made within **30 days** or your reservation will automatically cancel at the close of business.



- A \$75 Reinstatement Fee will be required if you wish to restore your reservation.
- Reminders will be sent to those subscribed to Monthly Payments on the 15th of the month.

Manual Payments

- If you choose NOT to do Automatic Billing, then you will be responsible for submitting manual payments via 1) Invoice or 2) Credit Card Authorization Form.
- Payment milestones will be established. At least 50% of the balance will be due by the
 halfway mark. If half of the balance is not paid by the established due date a Late Fee per
 person will be assessed. The exact due date and Late Fee will be indicated on your invoice.
- The processing fee on invoices is 3.5% of the total.
- Reminders will be sent to those subscribed to Invoice Payments on the 15th of the month.

Payment Plan Changes

 The agency will allow 2 complimentary changes to the payment plan (e.g., new pay date, new credit card). After 2 changes, a \$35 Change Fee will be applied to the balance for every change thereafter.

Card Declined

• If your card is declined, we will attempt to charge your card **3** days later. After **2** unsuccessful attempts your trip (and automatic billing) will be canceled.

Late Fees

• A Late Fee will be added to your balance **3 days** after a missed due date. Late Fees vary by trip. Please see the trip description for cost.

Consultation Fee

- This nonrefundable fee is for a travel professional to research multiple vendors and create customized quotes that best meets your needs. Once we receive the Consultation Fee we typically can provide a quote within 72 hours unless notified otherwise.
- Group quotes (7 people or more) that require a contract typically can take a week to obtain.
- If a reservation has not been made after **30 days** another Consultation Fee must be paid to continue to provide quotes.

REFUNDS & RESERVATION CHANGES

Travel Insurance

 We strongly recommend you purchase Cancel-For-Any-Reason trip insurance to protect your investment. We are happy to provide suggested suppliers for your trip including but not limited to: Travel Guard, Allianz Insurance, and Travel Safe.



Refunds and Cancellations

- All payments are nonrefundable. If you purchased insurance, a refund will be processed to the original credit card used for payment, or company check, minus the cost of the travel insurance.
- Request to cancel must be made in writing to Support@poshgetawaysbyparis.com.
- Cancellation fee is contingent upon the time of cancellation per the terms and conditions for each trip. After a Final Payment date, there will be a cancellation fee from the vendor because after the final payment date your reservation and accommodation will be confirmed. The cancellation fees can start at \$100 per person for administration costs.

Reservation Changes

- Passengers are responsible for ensuring their name (as listed on their Passport) and date-ofbirth is correct on their invoice and reservation.
- Minor Changes to an existing reservation will incur a \$35 per person charge plus any additional supplier fees. This includes: name changes, date changes, removal of services (i.e., optional tours, transfers), etc.
- Major Changes to an existing reservation, such as a new destination, will incur a \$350
 Modification Fee plus any applicable supplier change fees. Changing destinations after a
 trip has been booked is considered a new reservation and also requires changes to the
 existing reservation(s). The Modification Fee may be split across the group.
- Replacing a traveler with another traveling passenger constitutes a cancellation and is subject to cancellation penalties.

Last Minute Reservations

- Any reservation made **45 days** prior to departure will incur a **\$100 Rush Fee.**
- All reservations must be made no later than 30 days prior to departure. If requested services cannot be confirmed, payment will be refunded. If services are confirmed, final payment is due within 24 hours and all applicable cancellation penalties will apply.

Schedule Changes

- In the event of an airline schedule change, Posh Getaways by Paris, LLC will make every effort to inform passengers of the schedule change and new flight schedule prior to departure. Posh Getaways by Paris, LLC is not responsible for schedule changes including, when applicable, changes in routing and/or the number of stops in the itinerary.
- Posh Getaways by Paris, LLC is unable to provide compensation for schedule changes, seat assignment modifications, or cancellations implemented by an airline.
- In the event of any change in flight itinerary made directly between passengers and their
 airline, it is the passengers' responsibility to advise Posh Getaways by Paris, LLC of amended
 flight details in writing at Support@poshgetawaysbyparis.com. Posh Getaways by Paris, LLC
 cannot be held responsible for land services, including arrival and/or departure transfers, if
 flights are changed without its knowledge.



HOTEL INFORMATION

Hotel Accommodations

- All hotel rates are based on Posh Getaways by Paris, LLC agreements with its suppliers and are not negotiable.
- Although we will make a room request for you, bedding type, room selection, and amenities are **NOT** guaranteed and always subject to hotel availability. Room selection and bedding in all cases is strictly at the discretion of the hotel's management on a run-of-house basis.
- Triple and Quad occupancy rooms consist of two beds (usually queen size). The number of persons accommodated does not dictate the room size.
- Although available at most 4 and 5-star hotels, use of air-conditioning abroad differs greatly from the United States. Many European hotels were built before central air-conditioning was introduced. Air-conditioning is often shut down at night and from the end until the start of the summer months.
- Hotel check-in time is generally not before 3:00 p.m. and check-out time is prior to noon. Please be sure that adequate arrangements for accommodations have been taken into consideration when a late-night flight is being used.
- We reserve the right to make substitutions with hotels of equal standard. There will be no refunds for any difference in the cost of those accommodations.

Hotel Security Deposit

- Be prepared to pay a refundable security deposit upon check-in to cover incidentals such as parking or room service. The amount will vary by hotel, but a good estimate is \$100-\$150 per room. This deposit is fully refundable if there is no damage or smoking in the room.
- #POSHTIP: If using a debit card, the deposit will be deducted from your available balance.

Roommate Matching

- Roommate matching is available on certain tours and will be indicated in the trip description. Ultimately, it's the responsibility of the individual to find a roommate or they will have to pay the single occupancy rate.
- Guests can be matched once 75% of the balance has been received provided the roommate also has paid 75% of their balance. A list of eligible roommates will be provided.

RETREAT PLANNING SERVICES

Retreat Types

Posh Getaways by Paris is committed to offering a range of fully customizable retreat experiences, including but not limited to serene wellness retreats, empowering fitness camps, and healing grief retreats. Group Leaders are responsible for providing the guest list, retreat vision, and bringing a spirit of adventure!



 Group rates are contingent upon a minimum booking of 10 rooms, approximately equating to 20 participants.

Our Role

- Posh Getaways by Paris, LLC shall coordinate all travel logistics, including personalized itineraries encompassing hotel accommodations, flight arrangements, excursions, and other group activities as requested. Additionally, we can provide a custom website for the retreat or furnish the Group Leader with pertinent details and an Order Form for use on their own website. Participant Gift Bags and T-shirts may be included, subject to budget allowances.
- Meeting Space Coordination: Coordination with hotel management and/or designated facilities will be undertaken to ensure the provision of meeting spaces that align with the retreat's thematic requirements.
- We offer flexible payment plans, akin to those provided to other travel clients. Participants will have access to a Client Portal for making payments.
- Retreat Leader's Fee: The service fee for the Group Leader will be incorporated into the
 clients' travel payment and disbursed following the receipt of the Final Payment from
 clients. Regular reports of registered guests will be provided for tracking purposes. In the
 event of client cancellation, no service fee shall be disbursed.
- On-Site Support (optional): On-site hosting support is available with associated costs (including flight and hotel) to be included in the retreat expenses or covered by the Group Leader.
- Regular communication, including email updates and a Pre-Departure webinar, will be provided to prepare guests for the destination. Safety and emergency protocols will be clearly communicated to ensure client peace of mind.

Role of Group Leader

- The Group Leader (i.e., Retreat Leader) is responsible for defining the retreat's vision, agenda, and participant recruitment. They will set the retreat's tone, objectives, and activities and act as the primary liaison between the group and Posh Getaways by Paris.
- The Group Leader has primary responsibility for marketing the retreat to their ideal clients.
- A nonrefundable Retreat Planning Fee is required from the Group Leader to initiate the
 planning and quotation process. The Group Leader must also define their service fee to be
 collected along with the trip payment.
- To secure hotel rates, a group deposit is required. The Group Leader may choose to pay this deposit upfront or await guest bookings. It is important to note that prices are subject to change until the deposit is received.



GENERAL TRAVEL IN ORMATI

Identification

- Passengers are required to make reservations in the full name that is listed on their government-issued identification that they will use for travel. Passengers must ensure their name and birthdate is correct on all travel documents.
- If you need to make any changes to names or birthdates after travel documents have been issued, clients will be responsible for any associated change fees.

Passports and Visas

- All individuals departing from the United States of America must be in possession of a valid passport. It is your responsibility to ensure that you have valid travel documentation, including but not limited to passports and visas, which meet the requirements of immigration and other government authorities at every destination.
- Passengers are responsible for ensuring they have proper travel documents and must check with the respective consulate or visa agency to determine whether visa or passports are required.
- #POSHTIP: Most countries require passports to be valid 6 months after the date of travel.
- Any fines, penalties, payments or expenditures incurred as a result of such documents not meeting the requirements of those authorities will be your sole responsibility. A government issued ID is required for travel within the USA.

Travel Documents

- Upon receipt of full payment, final travel documents will be emailed (or mailed) approximately 2 weeks prior to departure.
- POSH Swag Bags (if applicable) are typically mailed 2 weeks prior to departure.

Airlines

- Posh Getaways is not responsible for the services and policies imposed by airlines.
- Airline schedules and flights are subject to change without notice.
- Once full payment is received, airline tickets will be issued and are nonrefundable.
- Any name change, even minor spelling corrections, are subject to full cancellation and rebooking fees at current rates.
- The airlines bear sole authority for seat assignments.
- Frequent Flyer Program:
 - Passengers are responsible for providing their frequent flyer number at the time of booking. Passengers should contact the airline directly to determine point eligibility and accrual rates as airlines update their frequent flier programs often.



Airport Transfers

- Airport transfers are provided, as indicated for each POSH Package by car, minibus, or motor coach if applicable. They can be shared or private transfers.
- If you purchase a land-only tour, or if you deviate from the arrival and/or departure dates as stated in the itinerary, you will have the responsibility to purchase your own transfer to the hotel.
- Posh Getaways by Paris, LLC or the transfer company will not be responsible for flight delays, for any reason, beyond **one hour** from your originally scheduled arrival time.
- In case of a delay, whether due to flight delay, immigration and customs, or time spent reporting baggage damage or loss, it will be your responsibility to make other transfer arrangements such as a taxi. Transfer costs are nonrefundable and any additional expenses will be your responsibility.

Sightseeing & Itinerary

- Posh Getaways by Paris, LLC tours have been designed to accommodate individuals as well
 as groups. Tours will be operated by motor-vehicle, its size dictated by the number of
 participants. We cannot guarantee the number of passengers who will be on any given tour.
 You may find that you are traveling with a sizeable group or only with your own
 companions. Services, however, will remain constant no matter the number of tour
 participants.
- Times listed in itineraries are approximate and meant only as guidelines.
- It is your responsibility to arrive on time for all scheduled flights, cruises, and package components. Arriving late may be considered a "no-show", in which case you will not be eligible for refund for the unused service(s).
- On dates including, but not limited to religious holidays and national celebrations, some monuments and sites may be closed. On these occasions, touring itineraries may be amended to reflect these closures. Occasionally, during holidays and certain periods, and/or due to unforeseen circumstances including weather conditions there may be last-minute changes, sometimes after arrival, in affecting the sequence of the tour, locations visited and/or hotels. Therefore, we reserve the right to adjust the sequence and/or substitute any hotels with others of similar category. In such cases there will be no cost adjustment.
- National monuments and tourist sites regularly undergo renovations, which can obscure the monument's view. No tour will be canceled due to renovations, however Posh Getaways by Paris, LLC will decide based on the conditions whether to amend an itinerary.
- Posh Getaways by Paris, LLC itineraries may contain suggestions for activities for your leisure time; these suggestions do not constitute an endorsement of any specific service provider and the decision to participate in any such activities should be made independently and with due consideration.



Health and Special Requirements

- It is your responsibility to ensure you are aware of any health requirements for your travel destinations and to ensure that you carry all necessary vaccination documentation.

- Client is fully aware of the current global Coronavirus COVID-19 virus outbreak, the current travel restrictions, and inherent risks involved if choosing to travel. Client should be aware that COVID-19 may impact elements of your trip and operation of some travel services.
- Client understands that it is his/her responsibility to check, understand, and comply with
 the latest travel information regarding this virus outbreak with the CDC
 https://wwwnc.cdc.gov/travel/notices, domestic governing bodies https://travel.state.gov,
 destination governing bodies, and all vendors associated with Clients travel.
- Client is aware that it is his/her personal decision to travel and is doing so with full knowledge of current travel recommendations, restrictions, and requirements with regards to the Coronavirus COVID-19 and takes full responsibility for his/her actions with regards to this.
- Client understands and confirms that this Agency, after reasonable inquiry, has made available to client, by reference, referral, or other conveyance, the best available



information known to this Agency regarding pandemic policies provided by travel suppliers and governing bodies, including but not limited to airlines, hotels, cruises lines, tour agencies, insurance provider, transfer agencies or any other entity involved in clients booking.

- Client is aware the travel warnings, travel restrictions and rules including screening and use

 enter or exit a destination as planned, related to Covid-19 and understands the risks, is

 provider, financial loss, quarantining rules or measures put in place at airports or
 destinations Client is traveling through.
- Client further agrees to hold this Agency harmless for any financial penalties or fees

 provider due to cancellations or postponements due to Covid-19 and agrees not to sue or
 institute a credit card dispute or "charge back" to this agency or its partners for said
 penalties, fees, or real or alleged damages.
